INFORMATION ABOUT POOR LOCATIONS:

Customer must provide a level job site, free of obstructions up to 4ft around outside for the use of ladders. If site is not level the customer is responsible for fixing the area and must provide blocking materials. When installing on a not level surface or with blocking materials it becomes very difficult to install properly, construction will be done best as possible but will be completed "AS IS". Customer is responsible for paying installers for additional time and labor required for leveling and blocking over 6 inches. If installed on blocking materials or a not level site, the customer must understand that additional anchoring is not only recommended but is their responsibility. Temporary re-bar stakes require more permanent anchoring system. It is the customer responsibility to inform us of an unsuitable or not level site before delivery. Installers need to be able to access the driveway and reach the construction site within 50ft. If installers arrive and are unable to install the building due to levelness, obstructions or an impassible driveway, the building will be delivered uninstalled and the full amount of contract is due. When issues are resolved customer may call for re-installation for a fee of 10% of the original contract price. No refunds on late cancellations or custom buildings. 30 day installation warranty with purchase of snow truss. Garage doors and leaks not warranted on gravel or non-level surfaces. Leaks on horizontal roof buildings not warranted, vertical roof option is for better drainage. No base or under building leak warranties offered. Caulking is not warranted. Wilson Mfg. Inc. holds no responsibility for acts of God or damages to property. All Rent to Own must be insured by the customer. If failure to make payment occurs, Wilson Mfg. Inc. retains all rights to access the property and remove building. Size may vary due to zero waste construction. For correct pad size call 606-871-7303. Do not install anchor bolts in concrete pad, installer will have to remove them. Customer is responsible for local permits, licensing fees, and engineering cost. Our delivery times range from 3-6 weeks with most installing within 2-3 weeks. Delivery dates and times are subject to change, without notice, due to delays with installments and weather. You will be contacted by Handi-Port at least 24 hours in advance for scheduling. If your are unable to accept the scheduling date, it may be another 2-3 weeks before we are in your area to install again. All orders are subject to verification by main office. Wilson Mfg. Inc. and its Subsidiaries, reserves the right to cancel any order for any reason at anytime during the orders process. Any credit card processing through Wilson. Mfg. 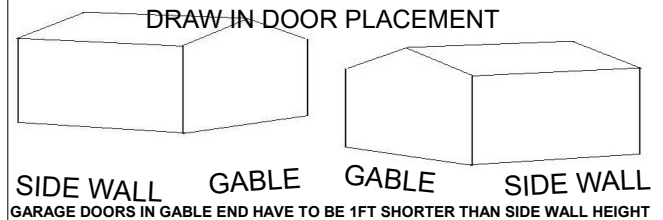
